I hereby certify, represent and warrant that all statements, disclosures and representations made by me in my application to participate in "The Fashion Show", in any other document or agreement that I have signed or will sign in connection with "The Fashion Show" are true, accurate and complete. Without in any way limiting the foregoing, I certify that I have not withheld or mischaracterized any information regarding myself or my background.
